This Indenture Made this 23rd day of November in the year of our Lord 1909 between Charles J. Stubling and Anna C. Stubling of The Dalles Wasco County Oregon the parties of the first part and Sophronia C. Evans of Stevenson Skamania County Washington, the party of the second part, witnesseth: That the said parties of the first part for and in consideration of the sum of two hundred dollars lawful money of the United States to them in hand paid by the said party of the second part, the receipt whereof is hereby acknowledged do by these presents grant, bargain, sell, convey and confirm unto the said party of the second part and to her heirs and assigns, the following described tract lot or parcel of land situate lying and being in the County of Skamania state of Washington and particularly bounded and described as follows: Lots five (5) and six (6) in Block three (3) of the Town of Stevenson Skamania County Washington as shown by the official plat of said town now on file and of record in the office of the Auditor of said County, together with the appurtenances to have and to hold the said premises with the appurtenances unto the said party of the second part and to her heirs and assigns forever. And the said parties of the first part for themselves and for their heirs, executors and administrators do by these presents covenant and agree to and with the said party of the second part her heirs and assigns that they are lawfully seized in fee simple of and in all and singular the above granted and described premises, that the same are free from all incumbrances and that they hereby warrant and defend the same from all lawful claims whatsoever.
