A strip of land six and one half ( $6\frac{1}{2}$ ) feet in width off the north side of Lot nineteen (19) and the whole of Lot twenty (20) in Block six (6) in the Town of Stevenson,according to the plat of said town as the same appears on file and of record in the office of the Auditor of said Skamania county Washington. To have and to hold the said premises with their appurtenances unto the said party of the second part and to his heirs and assigns forever,and the said parties of the first part for themselves and for their heirs executors and administrators do hereby covenant to and with the said party of the second part his heirs and assigns that they are the owners in fee simple of said premises and that they are free from all incumbrances and that they will warrant and defend the title thereto against all lawful claims and demands whatsoever.
