This Indenture Made the 4th day of March 1911 between Cooks Investment Co. a corporation duly organized under the laws of the State of Washington, whose principal place of business is at Cooks Skamania County State of Washington, the party of the first part, and John G.Wynn of Madison County of State of Wisconsin, party of the second part, witnesseth:

Together with all and singular the tenements hereditaments and appurtenances thereunto belonging or in anywise appertaining and the reversion and reversions remainder and remainders rents issues and profits thereof.
