Together with all and singular the tenements hereditaments and appurtenances thereunto belonging or in a nyw sie appertaining, and all its right title and interestof any kind wether at law or equity of, in or to the same and each and every part and parcel thereof To have and to hold the abre described and granted premises unto the said wind RiverLumber Co. its successors and assigns for ever
