Morrison of Grass Valley Oregon, have bargained and sold and by these presents do grant, bargain, sell and convey unto said T.C. Morrison and to his heirs and assigns the following described real property situated in the county of Skamania State of Washington:

Beginning at a stake 110 feet north of the one fourth corner on section line between sections 25 and 26 Tp. 3 N. R. 8 E. W. M. and on the north side of the Rock Creek and Collins Road, thence north 220 feet to a stake, thence west 140 feet to a stake on north side of said road, thence along the north side of road in an southeasterly direction to the place of beginning, containing one half (1/2) acre more or less, together with all and singular the tenements hereditaments and appurtenances thereunto belonging or in anywise appertaining and also all the estate right title and interest in and to the same including dower and claim of dower. To have and to hold the above described and granted premises unto the said T.C. Morrison his heirs and assigns forever/ And the above named grantors do covenant to and with the above named grantee his heirs and assigns that they are lawfully seized in fee simple of above granted premises that the same are free from all incumbrances and that they will warrant and defend the same against all lawful claims and demands of all persons whomsoever.
