ARNOLD TO BANK OF STEVENSON.

THIS INDENTURE, Made this 27th day of January, 1916, between W.A. Arnold, a single man, of Stevenson, Washington, party of the first part, and Bank of Stevenson, a banking corporation of the State of Washington, party of the second part:
