Lots twenty (20) and twenty one (21) in Block three (3) in the Town of Stevenson as shown by the official plat of said town now on file and of record in the office of the county Auditor for said County. To have and to hold the said premises with their appurtenances unto the said party of the second part and to his heirs and assigns forever. And the said parties of the first part do covenant to and with the said party of the second part that they are lawfully seized in fee simple of above granted premises, that the same are free from all incumbrances and that they will warrant and defend the same against all lawful claims.
