This Indenture witnesseth that William L. The said land being bounded as follows: The east line of said land being a line parallel to the west line of said lot six and seven. The west line being the west line of said lot six and seven. The south line coinciding with the south line of said lots six and seven. The north line coinciding with the north line of said lots six and seven.
