WADE TO HOME VALLEY IRRIGATION & POWER COMPANY.

Washington for and in consideration of the sum of One (\$1.00) Dollar paid by the Home Valley Irrigation & Power Company, a corporation, of washington, and for further good and valuable consideration unto it moving, and the conditions hereinafter contained, do hereby grant unto said Home Valley Irrigation & Power Company, its successors and assigns, a perpetual right - of-way Sixty (60) feet wide, for an irrigation ditch and power flume over and along said certain parcel of real property, the center line of which said strip is described as follows, being Thirty (30) feet wide on each side of said line, to-wit:
