

KNOW ALL MEN BY THESE PRESENTS, That Tyson Kinsell and Alma Kinsell, husband and wife, of Multnomah County, State of Oregon, in consideration of One Thousand Dollars to them paid by A.H.Anderson of Multnomah County, State of Oregon, have bargained and sold, and by these presents do grant, bargain, sell and convey unto said A.H.Anderson, his heirs and assigns, all the following bounded and described real property, situated in the County of Skamania and State of Washington: All of Lots numbered Eight (8) and Ten (10) of Section Twelve (12) in Township Three (3) North of Range Seven and One-Half (7½) East of the Willamette Meridian, containing 64.05 acres according to the United States Survey, this conveyance being subject to all reservations contained in patent from United States to Tyson Kinsell, together with all and singular the tenements, hereditaments and appurtenances thereunto belonging or in anywise appertaining, and also all their estate, right, title and interest in and to the same, including dower and claim of dower.

To Have and To Hold, The above described and granted premises unto the said A.H.Anderson, his heirs and assigns forever. And Tyson Kinsell, one of the grantors above named does covenant to and with A.H.Anderson the above named grantee his heirs and assigns that he is lawfully seized in fee simple of the above granted premises, that the above granted premises are free from all incumbrances, excepting the second half of the 1910 taxes, and except the reservations contained in said patent, and that he will and his heirs, executors and administrators, shall warrant and forever defend the above granted premises, and every part and parcel thereof, against the lawful claims and demands of all persons whomsoever except as aforesaid.
