D.G. JACKSON CO. TO VONDER AHE.

THIS INDENTURE, made on this 28th day of June A.D. 1916, by and between D.G. Jackson Co. a corporation organized and existing under and by virtue of the laws of the State of Washington, with its principal place of business at Underwood, therein hereinafter called the Mortgagor, and Minnie U. Vonder Ahe, of Hood River, Oregon, hereinafter called the Mortgagee, WITNESSETH, that the said mortgagor, for and in consideration of the sum of Sixteen Hundred and no/100 Dollars, United States Gold Coin \$6 it in hand paid, the receipt whereof is hereby acknowledged, has granted, bargained, sold and conveyed, and by these presents does grant, bargain, sell and convey unto the said Mortgagee, her successors, legal representatives, heirs or assigns, that certain real property situated in the county of Skamania and State of Washington, and described as follows, to-wit: All that portion of lot 3 of the Townsite of Underwood, as laid out and platted, and of record in the office of the county auditor described as follows: beginning at the southeast corner of said lot 3 running thence in a westerly direction along the south line of said lot 3 3 feet and 10 inches; thence in anotherly direction in a straight and direct line to the northeast corner of said lot 3; thence in a southerly direction along the east line of said lot 3 to the place of beginning; Also lot numbered 2 of the original town and Townsite of Underwood, Wash. as per the recorded plat thereof, filed by Amos Underwood on July 5th, 1904, and on said date
