

wide on each side of said line, to-wit:

Commencing at a point which is 684.5 feet West of the N.E. corner of the Southeast Quarter of the Southwest Quarter (S.E. $\frac{1}{4}$ of S.W. $\frac{1}{4}$) of Section Thirty-six (36) Township Four (4), North Range Seven one-half ($7\frac{1}{2}$) East of Willamette Meridian, thence S. $0^{\circ} 42'$ West for a distance of 1330.0 feet to a point which is 699.0 feet West of the South Quarter (S. $\frac{1}{4}$) corner Section Thirty-six (36) Township Four (4), North Range Seven One-half ($7\frac{1}{2}$) East of Willamette Meridian.

Said right-of-way is granted to be used by said Home Valley Irrigation & Power Company, its successors and assigns, for the purpose of constructing, maintaining, operating and repairing a ditch and flume for the purpose of irrigation and power, together with the right and privilege of entry upon said right-of-way with men, teams and appliances necessary and convenient for use in constructing, repairing, maintaining, operating and reconstructing said ditch and flume.

As a further consideration the grantee, its successors and assigns, hereby agree within a reasonable time to construct and operate a practical irrigation project upon said right-of-way, and to maintain same.

TO HAVE AND TO HOLD unto the said Home Valley Irrigation & Power Company, its successors and assigns, forever.
