NOTICE HEREBY IS GIVEN that the undersigned locators, each a citizen of the United States or one who has declared his intention to become such, have discovered a vein or lode of mineral bearing rock in place upon the unappropriated public domain of the United States within the State of ~~Oregon~~ ^{WASH} and said Mining District; and, in accordance with the laws of the United States, of the State of ~~Oregon~~ ^{WASH} and the regulations of said Mining District, have located and do hereby locate a claim upon such vein or lode by posting this notice of such discovery and location on a substantial post at the point of discovery, marked Post No. 1. The name of the claim is BIG TRINKLE # 2. Claim, further described as follows:

Commencing at a post marked No. 1 (Discovery Post), from thence

300 feet in a S. EASTERLY direction to an end post marked No. 2, thence
300 feet in a N. EASTERLY direction to a corner post marked No. 3, thence
1500 feet in a N. WESTERLY direction to a corner post marked No. 4, thence
300 feet in a S. WESTERLY direction to an end post marked No. 5, thence
300 feet in a S. WESTERLY direction to a corner post marked No. 6, thence
1500 feet in a S. EASTERLY direction to a corner post marked No. 7, thence
300 feet in a N. EASTERLY direction to said end post marked No. 2.

The locators claim 300 feet in a S. EASTERLY direction from point of discovery to the S. EAST end line and 1200 feet in the opposite direction from point of discovery to the N. WEST end line and 300 feet on each side of the middle of said vein or lode, further claiming all the surface rights,

privileges and minerals, with all dips, spurs, angles and variations, and other rights granted by existing laws and customs. This claim is further described as being 40 feet from a natural object or permanent monument in the vicinity, to-wit: SEC. 18 T. 4 N. R. 5 E. W.M. (use township and range, if possible)

THIS DISCOVERY CONSISTS OF MULTIPLE LODES AND DISSEMINATED COPPER WITH ASSOCIATED MINERALS.
PERMANENT MONUMENT BM 1159
