

Marble to Bethea ✓

This Indenture Made this 7th day of August 1911 between Guy Marble a single man of Council  
Idaho, the party of the first part, and Frank E. Bethea of Washougal Washington, the party of the  
second part Witnesseth: That the said party of the first part for and in consideration of the sum  
of four hundred (\$400.00) dollars lawful money of the United States to him in hand paid, the receipt  
whereof is hereby acknowledged have bargained and sold and by these presents do bargain, sell and  
convey unto the said party of the second part and to his heirs and assigns all the following  
described real estate situated in the county of Skamania State of Washington to-wit:  
The East half of the southeast quarter of the Southwest quarter of section eight (8) Township one  
(1) North of Range five (5) East of Willamette Meridian containing 20 acres; the party of the second  
part here by assumes and agrees to pay that certain mortgage for \$100.00 now on said property  
which mortgage is dated May 27th 1909 and was given to Fred Lidstone and was due three years after  
date. Together with all and singular the tenements hereditaments and appurtenances thereunto  
belonging or in anywise appertaining. To have and to hold all and singular the above described  
and mentioned premises together with the appurtenances unto the said party of the second part his  
heirs and assigns forever. And the said party of the first part and his heirs and assigns, the said  
premises and a quiet and peaceable possession of said party of the second part his heirs and  
assigns and against the said party of the first part and all and every persons whomsoever lawfully  
claiming or to claim the same, shall and will warrant and by these presents forever defend.

This deed made this 14th day of July 1911 between Columbia Railway and Navigation Company a  
corporation under the laws of the State of Washington hereinafter called the Navigation Company  
party of the first part, and Spokane Portland & Seattle Railway Company a corporation under the laws  
of the State of Washington hereinafter called the Railway company, party of the second part, Witnesseth:  
Whereas the stockholders of the said Navigation Company at a meeting held on the 1st day of July  
1911 unanimously consented to this conveyance and the Board of trustees of said Navigation company  
at a meeting of said board duly held on the 1st day of July 1911 duly authorized and directed the  
execution of this conveyance; Now therefore in execution of the power and authority and in pursuance  
of the direction given by said Board of trustees and by said stockholders and in consideration  
of one dollar to the Navigation company paid by the Railway company, receipt whereof is hereby  
acknowledged and of other good and valuable considerations, the Navigation company hereby bargains  
sells, grants and conveys to the railway company all the property and rights of property of every
