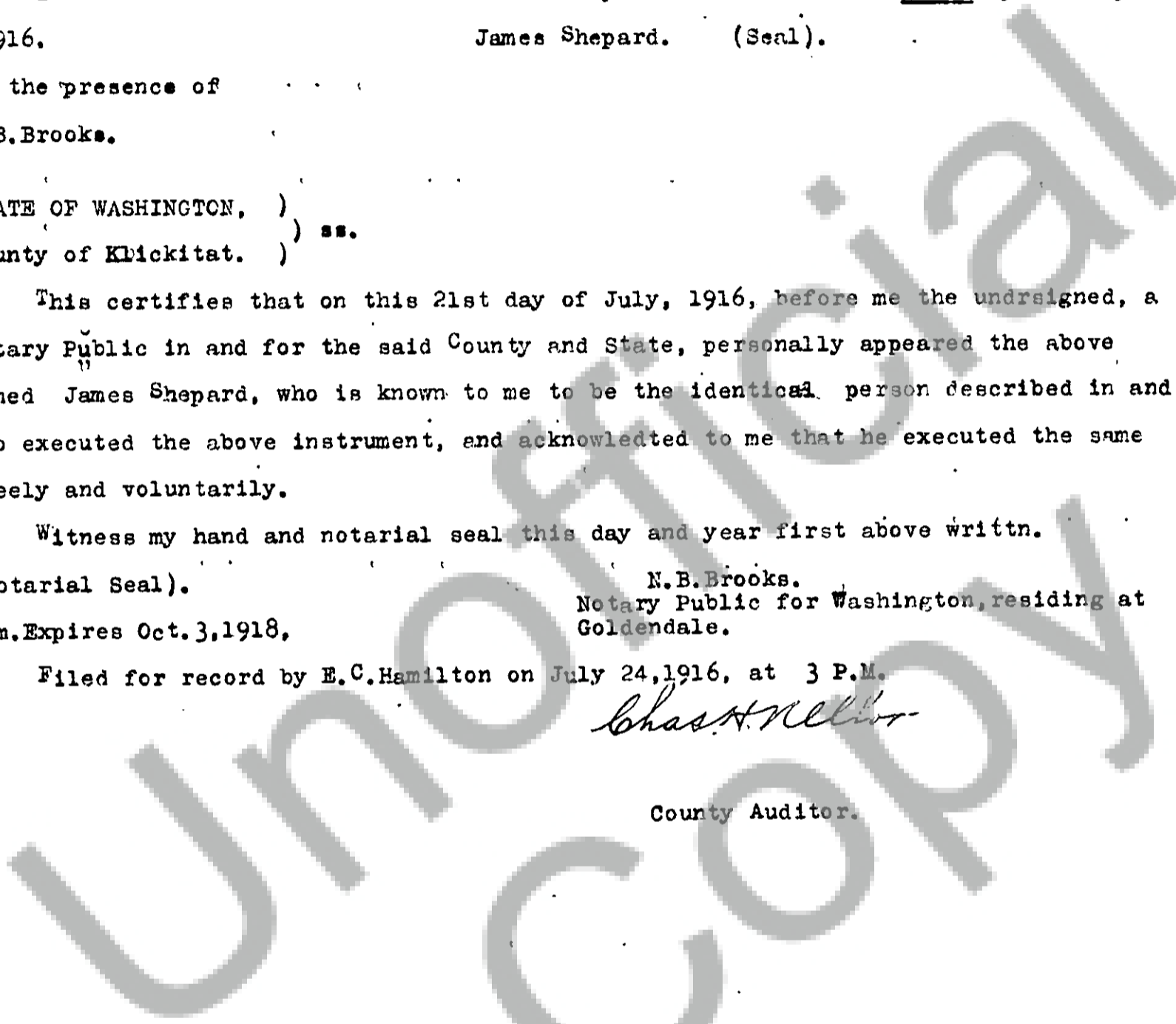
STEVENSON TO PRESTON.
