This Indenture made this 23rd day of December 1910 by and between the Oregon Railroad and Navigation Gempany (here inafter called the vendor) a corporatio organized and existing under the laws of the State of Oregon, and Oregon Washington Railroad & Navigation Company (hereafter called the Vendoe) a corporation organized and existing under the laws of the State of Oregon.

Whereas the Board of Directors of the vendor and the Board of Dir ctors of the Vendoe have agreed upon the grant, sale conveyance and transfer her inafter set forth and such grant, sale conveyance and transfer has been authorized and consented to approved and ratified by the holders of more then seventy five per cent of the common capital syock and by the holders of more the seventy five per cent of the pre ferred stock of the vendor and has also been authorized and consented to approved an ratified by the holders of mr then seventy five per cent of the capital stock of the Vendoe:

Now therefore this indentur Witnesses that for and in consideration of the covenants of the vendoe herein containined and of the sum of fifty five million dollars lawful money of the United States paid by the vendoe to the vendor at or before the enscaling and delivery of these presents, the receipt whereof is herebyacknowledged the vendor has granted bargined sold assigned transferred released and conveyed and by these presents does grant bargain sell trasnferr release and convey unto the vendoe its successors and assigns:

(a) All of the Railroads and telegraph lines of the vendor together witj all the rights powers immunitites privileges franchises and all otherproperty appetaining thereto including the lines of railroad and telegraph line described as follows:

- 1. From Portland to Huntington through the counties of Multnomah, Hood River, Wasco, Sherman, Gilliam, Merrow , Umatilla Union and Baker, all in the State of Oregon. 2. From Unatilla Junction in the State of oregon via Wallula in the State of Washington to Walla Walla in the State of Washington, through the county of Umatilla in the state of regon and the cou ty of Walla Walla inthe State of Washi gton. 3. From Pendleton in the state of oregon via Walla Walla , Grange City and Colfax in the state of Washington through the county of Umatilla in the State of Oregon and the counties of Walla Walla, Celumbia, Whitman and Spokane in the state of Washington. 4. From Heppner Junction formerly known as Willows Junction, to Heppner thorugh Counties of Gilliam and Horrow all in the State of Oregon. 5. Brom La grande via Elgin and Wallowa to Joseph thorugh counties of Union and Wallewa in the State of Oregon. 6. From Starbuck to Pomercy thorugh the counties of columbia and Garfield in the state of Washington. 7. From Connell to La crosse thorugh the counties of Franklin Adams and Whitman all in the state of Washington. 8. From Colfax in the state of Washington to Mosrow in the state of Idaho through the counties of whitman in Washington and Latah in the state of Idahow. 9. From Bolles Junction via Dayton to Turner thorught the counties of Walla Walla and columbia in the State of Washington. 11. From Tekoa in the State of Washington to Mullan in the State of Idahe thorugh the counties of Whitman in State of Washington and Counties of Kootenai and Sheshone in the State of Idaho. 12. From Wallace to Burke all in the county of Shoshone in State of Idaho. 12. From Sierra Nevada Junction to Sierra Nevada Mines all in the county of heshone in the state of Idahe.14. From Fraifield to Waverly all in the County of spokane Washi gton. 15. From Portland via St. Johns to Troutdale all in the County of Multnomah, State of Oregon and in connection therewith a cutoff by a tunnel thic ugh the peninsula between the Columbia and inillamette Rivers. 16. From Portland State of Oregon on s eme eligible route to be her after selected to a point at or near the moj th of the Columbia River on e ther the north or south side of sis river. 17. From Coyote te Stanfield all in the county of Umatilla State of Oregon .
- (b) All right interest and estate of the vendor in, under or to any and all leases of any railroads or telegraph lines or other property including the lease of the vendor of the property of the Northern Pacific Terminal Company of regon and all right of the vendor to purchase property of said Terminal Company situated on the east side of the millamette River at Portland Oregon and all title interest and estate of the vendor in and to said property the legal title of which is in sai
