Froeschle, husband and wife of the county of Skamania State of Washington parties of the first part, and Anthony Zahradnik and Lottie Zahradnik husband and wife, of the County of Multnomah State of Oregon, party of the second part, WITNESSETH, That the said parties of the first part, for and in consideration of the sum of One Thousand (\$1000.00) Dollars, to them in hand paid the receipt whereof is hereby acknowledged, have bargained, sold, aliened, released, conveyed, and confirmed, and by these presents do bargain, sell, alien, release, convey and confirm unto the said parties of the second part, their heirs and assigns forever, all Beginning at the northeast corner of the southeast quarter (SE $\frac{1}{4}$ ) of the southwest quarter (SW $\frac{1}{4}$ ) of Section three (3) in Township one (1) north of range five (5) East of Willamette Meridian, and running thence south four hundred seventy and five tenths feet (470.5) thence west Nine hundred and fifty two feet (952') to the County road; thence northerly along said county road, to a point west of the point of beginning, thence east eight hundred and eighty five (885) feet to the point of beginning containing ten (10) acres all in the county of Skamania State of Washington.

TOGETHER with the tenements, hereditaments and appurtenances thereunto belonging or in any wise appertaining; and also the estate, right, title and interest of the said party of the first part, of, in and to the same. TO HAVE AND TO HOLD the hereinbefore granted, bargained and described premises, with the appurtenances, unto the said parties of the second part their heirs and assigns forever.
