

This Indenture Witnesseth, That Neil Williams__ party of the first part, for and in consideration of the sum of One Dollar and other good and valuable considerations Dollars, lawful money of the United States of America, to him in hand paid by "The Trapper Creek Mining Co." party of the second part, does by these presents remise, release, convey and quitclaim unto said party of the second part its heirs and assigns, all interest of the said party of the first part in and to the following described real property, situated in Skamania County, State of Washington, to-wit: The Neil Williams Lode Mining Claim on Trapper Creek, discovery beginning at the discovery stake from which bears as a witness a cross chisled in the face of a cliff and bears N 48°42" E 10.0 feet dist from discovery stake a fir 20 inches diameter S 53°10' W 62 feet, a green fir 26 inches diam S 7°00' E 70.3 feet. The crest of the first falls between 40-50 feet in height bears S 87°14 W 294.5 feet. These falls are on Trapper Creek. Thence S 51° 53' W 300' Thence N 38°07 W 1500 feet to S.E. corner of Edward Anderson claim from which bears a fir 60 inches diam N 47° W 49 feet a larch 20 inches in diam S 75° E 12.2 feet Thence N 51° 53 E 300 feet to center line on west end of said claim from which bears a forked hemlock 36 inches diameter N. 18°00 W 13.0 feet distant a hemlock 30 inches Diam S 70°00 E 10.0 ft dist. Thence N 51° 53 E 300 feet, thence S 38°07' E 1500. thence S 51° 53' W 300 feet to point of beginning and to discovery stake.
