FOOTS TO FIRST NATIONAL BANK.

THIS INDENTURE WITNESSETH, That Seneca Fouts, unmarried of Multnomah County, State of Oregon, party of the first part, for and in consideration of the sum of Nineteen Hundred (\$1900.) Dollars, to him in hand paid, the receipt whereof is hereby acknowledged, has bargained, sold and conveyed, and by these presents does bargain, sell and convey unto FIRST NATIONAL BANK, Hood River, Oregon, party of the second part, the following described premises, situated in Skamania County, Washington, to wit: "The south half of the southeast quarter, the southeast quarter of the southwest quarter of section nine, and the southwest quarter of the southwest quarter of section ten, in Township three north, of range Nine east of the Adlamette Meridian, containing 160 acres."

"Also that certain ware house building owned by the mortgagor herein, situated on the right of way of the S.P. & S. Ry. Co., in the town of Cooks, Skamania County, Washington." Together with the tenements, hereditaments and appurtenances thereunto belonging, or in anywise appertaining. To Have and to Hold the same, with the appurtenances, unto the said party of the second part, its successors and assigns, forever.
