The East Half ( $\frac{1}{2}$ ) of the southeast quarter ( $\frac{1}{4}$ ) and the southeast quarter ( $\frac{1}{4}$ ) of the northeast quarter ( $\frac{1}{4}$ ) of Section twenty two (22), Township two (2) North, Range Five (5) East, Willamette Meridian, to secure the payment of the sum of Six Hundred and no/100 (\$600.00) Dollars, and the interest thereon, in accordance with the tenor of a certain promissory note of which the following is a copy, to wit:

not so paid, the whole sum of both principal and interest to become immediately due and collectible, at the option of the holder of this note. And in case suit or action is instituted to collect this note, or any portion thereof, we promise and agree to pay, in addition to the costs and disbursements provided by statute such additional sum in like Gold Coin as the court may adjudge reasonable, for attorney's fees to be allowed in said suit or action.
