All of Lot number (16) of Seeley's Subdivision of the southwest quarter of section nineteen (19) Township three (3) North of Range ten (10) East of Willamette Meridian in the County of Skamania,State of Washington. together with all and singular the tenements hereditaments and appurtenances thereunto belonging.
