And the Mortgagors promise to pay said note, according to the terms thereof, and also all taxes on said premises, including taxes, on this mortgage, if any, or the money secured thereby; and in case of default in the payment of the said note, or any installment of interest thereon or any of said taxes, when due, the Mortgagee or assigns may fore close this mortgage, both as to principal and interest, and may include in the fludgment on such foreclosure a reasonable counsel fee, together with all payments made by the mortgagee for taxes on said premises, including taxes, on this mortgage, if any, or the money secured thereby, and for insurander on the buildings on said premises, and for any adverse claims to the mortgaged property; all of which payments the mortgagee is hereby authorized to make; and such payments, with interest thereon at the rate specified in said promissory note, together with the counsel fee aforesaid shall be secured by this mortgage, and payable to the mortgagee in U.S. Gold Coin out of the proceeds of the sale under said foreclosure.
