KNOW ALL MEN BY THESE PRESENTS, that Andrew Zurcher, of Carson, Skamania County, Washington, party of the first part, for and in consideration of the sum of Five hundred dollars, lawful money of the United States, in hand paid by Gust J.Melonas, of Stevenson, Skamania County, Washington, party of the second part, the receipt whereof is hereby acknowledged, does by these presents grant, bargain, sell and assign, transfer and set over unto the said party of the second part, a certain indenture of mortgage bearing date the 5th day of December, 1916, made and executed by Lewis Eyman and H.C.Eyman,
