Northwestern E.Co. to Cameron. ✓

Know all men by these presents that the Northwestern Electric company a corporation in consideration of one dollar and other good and valuable considerations to it paid by R.D.Cameron does hereby grant and convey to said R.D.Cameron his heirs and assigns forever a right of way across the following described real estate situate lying and being in the counties of Skamania and Klickitat in the state of Washington to-wit:

The Northeast quarter of the Northeast quarter of the Northwest quarter of section ten (10) in Township three (3) North of Range ten (10) East of the Willamette Meridian said right of way as now laid out used by said R.D.Cameron being for the purpose of maintaining that certain pipe line as now laid and used by said R.D.Cameron, granting unto said R.D.Cameron his heirs and assigns the right to enter upon the above described property for the purpose of keeping said pipe line in repair. The said Northwestern Electric Company proposes to build a dam and flood the present bridge and pipe and before doing so/agrees to relay said pipe across the flooded area as follows: Two logs shall be laid across the river and bolted to the rocks on both sides, the pipe shall be laid on these logs and securely fastened thereto; so that the entire structure will be held solidly in place and the pipe protected from any floating debris in the water, when the structure shall be flooded, and the said R.D.Cameron his heirs and assigns agrees to pay for said relaying the cost thereof not to exceed the sum of one hundred fifty dollars (\$150.00). The said Northwestern Electric Company reserves the right to change the location of said pipe line at any time at its own expense to any other part of the above described property than the same is now located, but such change shall not interfere with the use of the water, except temporarily.

To have and to hold the same unto the said R.D.Cameron, his heirs and assigns forever.
