Lindsay, party of the second part, have granted bargained and sold and by these presents do grant bargain sell and convey unto said party of the second part his heirs and assigns the following described real property situated in the County of Skamania State of Washington to-wit:

Beginning at a point five hundred feet (500ft) south of the Northwest corner of the H. Shepard D. L. C., thence south 222.60 feet, thence south 74 deg. 52 Min East 353.50 feet, thence north 24 deg 46 min West 292.90 feet, thence north 74 deg. 52 min West 222.20 feet to the place of beginning containing 1.50 acres more or less, situate in Lot numbered 8 of Stevenson Park Addition, according to the plat thereof filed by R.
