Greene to Chesser ✓

This Indenture Made this 25th day of November 1911 between Albert R. Greene and Julia C. Greene husband and wife of Stevenson Washington, the party of the first part, and G.C. Chesser of the same place, party of the second part witnesseth: That the said party of the first part for and in consideration of the sum of twelve hundred (\$1200.00) dollars lawful money of the United States to him in hand paid by the said party of the second part the receipt whereof is hereby acknowledged have bargained and sold and by these presents do bargain, sell and convey unto the said party of the second part and to his heirs and assigns the following bounded and described real property lying and being in the County of Skamania State of Washington to-wit:

Beginning at a point six hundred and sixty (660) feet west of the center of section thirty six (36) in Township three (3) North of Range seven (7) East of Willamette Meridian, running thence South nine hundred forty two (942) feet to the north side of Rock Creek Hot Springs Road; thence along the north side of said Rock Creek Hot Spring Road as follows: South 33 deg 50' East 246 feet; thence south 42 deg 10' east 130 feet; thence South 60 deg 25' East 190 feet; thence north 11 deg 19' West 357 feet (this point being 990 feet south of the line running east and west through center of section 36), thence north 894 feet to the southline of the Cropper road; thence in a northwesterly direction along southerly side of said Cropper road to the point of beginning containing seven (7) acres more or less.
