ALLEN & LEWIS to RODLUN.

KNOW ALL MEN BY THESE PRESENTS: That Allen & Lewis, a corporation, of the State of Oregon, the party of the first part, for and in consideration of the sum of Fifty (\$50.00) Dollars Gold coin of the United States of America, to it in hand paid by O.N. Rodlun, of Boring, Oregon, the party of the second part, the receipt whereof is hereby acknowledged, has granted, bargained, sold and assigned, transferred and set over, and by these presents does grant, bargain, sell, assign, transfer and set over unto the said party of the second part, a certain Indenture of Mortgage bearing date the 27th day of April, A.D. 1915, made and executed by N.A. Rodlun and Laura A. Rodlun, husband and wife, to Allen & Lewis, a corporation of the State of Oregon, the Mortgage therein, to secure the payment of the sum of One Hundred twenty nine and 69/100ths (\$129.69) Dollars, together with the note or obligation therein described, and the money due, or to grow due thereon, with the interest and covering the following described real property in Skamania County, State of Washington, to-wit:

The souteast quarter of the northwest quarter and the lots Numbered Three (3), Four (4) and Five (5), of Section six (6), in Township three (3), North of range nine (9), East of Willamette Meridian; containing One Hundred fifty seven and 63/100ths (157.63) acres, which said Indenture of Mortgage was recorded in the office of the County Clerk of the County of Skamania, State of Washington, in Book M, record of Mortgages, page 551, on the 28th day of April, A.D. 1915.

TO HAVE AND TO HOLD the same unto the said party of the second part, his executors, administrators and assigns, for his use and benefit, subject only to the proviso in the said Indenture of Mortgage mentioned.
