DEHART et ux to DE TWEED NORTHWESTERN and PACIFIC HYPOTHEEKBANK

THIS INDENTURE, Made and entered into this fourth day of April A.D. 1917, between Fredrick W. Dehart and Delcia A. Dehart his wife, of the County of Skamania and State of Washington, parties of the first part (hereinafter called "mortgagor") and the De Tweede Northwestern and Pacific Hypotheekbank, a Corporation formed under the General Laws of the Kingdom of the Netherlands, whose principle place of business is in the City of Amsterdam, Kingdom of the Netherlands (hereinafter called "mortgagee"), party of the second part,

WITNESSETH, That the said mortgagor, for and in consideration of the sum of Eight Hundred Dollars (\$800.00) in Gold Coin of the United States of America, in hand paid by the said mortgagee, the receipt of which is hereby acknowledged, does by these presents, grant, bargain, sell and convey unto the said mortgagee, its successors and assigns, all of the following described real estate, lying and being situated in the County of Skamania and State of Washington, to-wit:
