

DOUMITT to ELLIS

KNOW ALL MEN BY THESE PRESENTS, That N.S. Doumitt and unmarried man, of Stevenson, Skamania County, Washington, party of the first part, for and in consideration of the sum of one thousand dollars (\$1000.00) lawful money of the United States of America, to him in hand paid by Lena Ellis, of Ranier, Oregon, party of the second part, the receipt whereof is hereby acknowledged does by these presents, grant, bargain sell, assign, transfer and set over unto the said party of the second part, a certain INDENTURE OF MORTGAGE, bearing date, the 9th day of December, 1916, made and executed by William H. Miller and Mary A. Miller, his wife, to N.S. Doumitt, to secure the payment of One thousand Dollars (\$1000.) , with interest thereon at eight percent (8%) per annum from date until paid, and recorded in the office of the County Auditor of Skamania County, Washington, in Book "N" of Mortgages, at page 343, on the 16th day of December, 1916, together with the promissory note therein described, and the money due or to become due thereon, with interest.

And the said party of the first part does hereby make, constitute and appoint the said party of the second part his true and lawful attorney, irrevocable in his name, or otherwise, but at the proper costs and charges of the said party of the second part, to have, use and take all lawful means for the recovery of the said money and interest; and in case of payment, to discharge the same as fully as the said party of the first part might or could do if these presents were not made.
