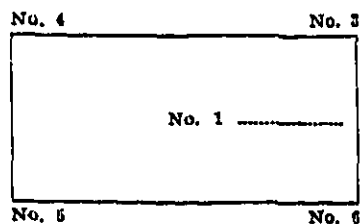

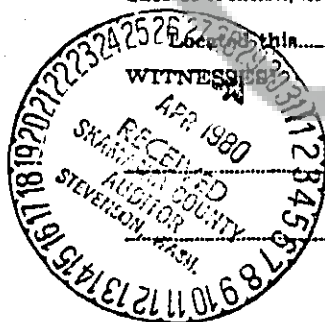
1200' feet in a EAST
