Lawer Commission

And in any suit or other proseedings that may be had for the recovery of said principal sums and interest on either said note or this mortgage, it skall and may be lawful for the said party of the second part its successors, heirs exeutors, administrators, or assigns, to include in the judgement that may be recovered, in addition to the costs provided by law counsel fees and charges of attorneys and counsel employed in such foreclosure suit the sum of fourty Dollars, as well as all payments that the second party of the second part its successors, heirs, executors, administrators or assigns may be obliged to make for itself or their security by insurance or on account of any taxes, charges, incumbrances or assessments whatsoeser on the said premises or any part thereof.
