The Grantors Edward R.Wright and Margaret E.Wright (husband and wife) of Washougal Clarke County Washington, for and in consideration of twelve hundred (\$1200.00) dollars in hand paid, convey and warrant to A.B.Herndobler the following described real estate situated in the County of Skamania State of Washington to-wit:

The East one half ($\frac{1}{2}$) of the southwest quarter ($\frac{1}{4}$) of the southeast quarter ($\frac{1}{4}$) of section six (6) in Township one (1) North of Range five (5) East of Willamette Meridian, containing 20 acres As a part of the consideration of this deed the grantors hereby reserve to the northwestern Electric Company the right to carry power over two (2) pole lines with wires suspended over the southwest corner of the land above described, but no right to erect poles on the herein granted land is reserved. The said right to suspend wires having been heretofore granted.

Know all men by these presents that we, Sarah Estelle VanAlstine Weber and Henry K.Weber husband and wife of Skamania County Washington in consideration of ten (\$10.00) dollars in hand paid the receipt whereof is hereby acknowledged have bargained and sold and by these presents do bargain grant, sell and convey to Jonathan A.Holmes of Sudbury Ontario the following described real property situate in the County of Skamania State of Washington to-wit:

All of that certain tract commencing at the Northwest corner of section 19 Township North of Range 10 East of Willamette Meridian running thence easterly along the north line of said section 19 to the northeast corner of the Northwest quarter of said section 19, thence southerly along the east line of said Northwest quarter 662.25 feet to an iron pipe; thence westerly 695 feet to an iron pipe, thence north 248.75 feet to an iron pipe, thence westerly 1852 feet to the west line of said section 19 to a point 417 feet south of said northwest corner of said section 19, thence along said west line northerly 417 feet to the place of beginning, containing 28.25 acres more or less.
