STOPPER- STOPPER.

THIS INDENTURE, Made this 14th day of May A.D. 1917 by and between L. Stopper, husband  
and wife, parties of the first part, and Robert Stopper party of the second part,

WITNESSETH, That, whereas, the party of the second part has loaned to the parties  
of the first part the full sum of Twenty Three Hundred Dollars, which sum the said  
parties of the first part agree to repay Three Years after this date, and to pay interest  
thereon at the rate of seven per cent per annum as to \$500.00 and six per cent per  
annum as to \$1800. from date untill paid; and also to pay all taxes and assessments  
which may be levied to or against the party of the second part, or assigns, on account  
of such loan. All according to the terms of a certain promissory note, of which the  
following is a copy

May 14th 1917.

Three years after date without grace, I promise to pay to the order of Robert Stopper  
at Portland, Oregon Twenty-three Hundred Dollars, in Gold Coin of the United States  
of America, of the present standard value, with interest thereon in like Gold Coin  
at the rate of seven per cent per annum as to \$500. and six per cent per annum as to \$1800.  
from date until paid, for value received. Interest to be paid semi-annually and if not  
so paid, the whole sum both principal and interest to become immediately due and collectible  
at the option of the holder of this note. And in case suit or action is instituted to  
collect this note, or any portion thereof, I promise and agree to pay, in addition to the  
costs and disbursements provided by statute, such additional sum, in like Gold Coin, as the  
Court may adjudge reasonable, for Attorney's fees to be allowed in said suit or action.
