

Gregg to McDonald ✓

This Indenture made this 18th day of December 1911 between E.L.Gregg and Melissa D.Gregg his wife of Minneapolis, County of Hennepin State of Minnesota, party of the first part, and Allen McDonald of Portland, Oregon, party of the second part Witnesseth: That the said party of the first part, for and in consideration of the sum of one dollar (\$1.00) and other valuable considerations to them in hand paid by the said party of the second part the receipt whereof is hereby acknowledged, does hereby grant, bargain, sell and convey unto the said party of the second part their heirs and assigns forever, all that tract or parcel of land lying and being in the County of Skamania State of Washington, described as follows to-wit:

South half (S $\frac{1}{2}$) of North half (N $\frac{1}{2}$) of Section thirty-four, (34) in Township three (3) North of Range seven (7) East of W.M., containing one hundred sixty (160) acres according to Government survey thereof. To have and to hold the same together with all the hereditaments and appurtenances thereunto belonging or in anywise appertaining unto the said party of the second part their heirs and assigns forever. And the said E.L.Gregg and Melissa Gregg his wife, party of the first part for themselves and for their heirs and assigns do covenant to and with the said party of the second part their heirs and assigns that they are well seized in fee simple of the lands and premises aforesaid and have good right to sell and convey the same and that the same are free from all incumbrances and the above bargained and granted premises in the quiet and peaceable possession of the said party of the second part, against all persons lawfully claiming or to claim the same the said party of the first part will warrant and defend.
