

is hereby set off as the part of said Simeon Iman the following described property to-wit:

Beginning at a post at the Northeast corner of the Daniel Baughman donation land claim in sec.1 in Township 2 North of Range 7 East of W.M. thence south along the east line of said donation land claim 6 chains and 63 links to the meander line on the north bank of the Columbia River being the southerly line of said Daniel Baughman D.L.C.; thence north 77° and $1/2^{\circ}$ West 2 chains and 38 links along said boundary line; thence north 6 chains and 14 links to the north boundary of said claim, thence east 2 chains and 33 links along said boundary to place of beginning containing one acre and one half acre more or less of land and all being in said Donation land claim and is the sole and separate property of said Simeon Iman and that all the balance of said claim which is fully described in said plaintiff's complaint and in said decree is set off and confirmed in said plaintiff subject to the deed of division made by and between plaintiff and defendant the Cascade Land and Investment company and in addition thereto said plaintiff is declared to be the owner in fee simple of $W\frac{1}{2}$ of $SE\frac{1}{4}$ and $E\frac{1}{2}$ of $SW\frac{1}{4}$ of sec.35 township 3 North of range 7 East of W.M.. In order that there may be more particularly of description. It is further ordered and decreed that the following described land be set off and confirmed in said plaintiff to-wit: The west half of the southeast quarter and the east half of the Southwest quarter of section 35 in Township 3 North of Range 7 East of W.M. and also an undivided three fourth of easterly half of Daniel Baughman Donation land Claim beginning at the southeast corner of said donation land claim, thence running north on the east line about 9 chains to the northeast corner of said claim, thence west on the north line of said claim 76 chains to the northwest corner of said claim; thence south on the west boundary of said claim 9.09 chains; thence in straight line in a southeasterly direction along the division line between the east and west half of said claim to a post on the banks of the Columbia River marked D.B.F.G.I.; thence up the Columbia River on the meander line of said donation claim to the place of beginning, subject however to that part herein ordered set off to Simeon Iman and Rock Creek Island which has already been decreed to belong to said plaintiff and also saving and excepting therefrom that part heretofore conveyed to Lewis F Iman by Felix G. Iman and Margaret Iman which deed was duly recorded in the office of the County Auditor of Skamania County Washington Nov. 1st 1903 in Book E of deeds at page 44; said above described land being the east part of the Daniel Baughman Donation land claim composed of parts of sections one and two in Township two North of Range 7 East of W.M. It is further ordered that said parts set off is hereby adjudged the sole and separate property of the said respective parties free and clear of all claims of the said parties hereto and that each party pay his own costs herein.
