Morrison to Jackson. ✓

THIS INDENTURE WITNESSETH, That Thomas C. Morrison and Lettie A. Morrison; husband and wife, of Grass Valley, State of Oregon, the grantors, for and in consideration of the sum of Five Thousand Dollars, in lawful money of the United States, to us in hand paid by R.E. Jackson of Klickitat County, State of Washington, the grantee, have Granted, Bargained and Sold, and by these presents do Grant, Bargain, Sell, Convey and Warrant unto the said grantee and to his heirs and assigns, the following described real estate situated in the County of Skamania State of Washington, to-wit:

All of South-West quarter, Section Twenty five (25) Township three (3) North Range Eight (8) East Will. Mer. Save and except Nine and one Sixteenth (9-1/16) acres in the Northwest corner of said quarter section; particularly described as follows; being 50 rods South, Thence 29 rods East; thence 50 rods North; thence 29 rods West, to said corner post.... Also except, Fourteen and one half (14--1/2) acres more or less, on the South side of the Southeast quarter of said South-west quarter; of Section Twenty Five (25) Township Three (3) North Range Eight (8) East Will.
