KNOW ALL MEN BY THESE PRESENTS, That E.E. Million the party of the first part, for and in consideration of the sum of Six Hundred (\$600.00) Dollars, lawful money of the United States of America, to her inhand paid by Vida M Gage, of #431 East 34th Street Portland Oregon, the party of the second part, the receipt of which is hereby acknowledged, has granted, bargained, sold, assigned, transferred and set over, and by these presents do grant, bargain, sell, assign, transfer and set over, unto the said party of the second part a certain INDENTURE OF MORTGAGE, bearing date the second day of March, A.D. One Thousand made and executed by B.B. Moore and conveying all his right title and interest to Premises therein disclosed as follows, N.W. 1/4 of NW 1/4 of section 17 Twp 3 North of Range 10 EWM, containing 40 acres, in Skamania Co. Wn. and assigned to the said party of the first part to secure the payment of the sum of Six Hundred (\$600.00) Dollars, together with the Promissory Note or obligation therein described, and the money due or to grow due thereon with the interest; which said Indenture of Mortgage was recorded in the office of the Auditor of the said County of Skamania State of Washington, in Book N of Mortgages page 380 on the seventh day of March, A.D. 1917.
