- (1) Tender to the said Continental and Commercial Trust and Savings Bank and Fank H. Jones full compensation for all services up to this time perferred performed by them and payment of all expenses and obligations incurred by them as such Trustee:
- (2) Offer sufficient and satisfactory indemnity to said continental and Commercial Trust and Savings Bank and Frank H. Jones, Trustee, against any liability for any act done or performed by them under said deed or trust:
- (3) Remove said Continental and Commercial Trust and Savings Bank and Frank.H.Jones as Trustee under said Deed of Trust.

Name and appoint WILLIAM H.PUTNAM., of Red Wing, Minnesota, as the sole Trustee under said Deed of Trust and as the sole successor to said Continental and Commercial Trust and Savings Bank and said Frank H.Jenes, under said deed of trust.
