This Indenture made this 25th day of April 1912 between Mary Virginia Gray and Harry L. Gray her husband, the parties of the first part and Isadore St. Martin, ----- Long, Maggio Reid, Katherine Haines, Olivia Davey, Luther St. Martin, the parties of the second part, Witnesseth: That the said parties of the first part for and in consideration of the sum of ten dollars and other valuable considerations lawful money of the United States to them in hand paid by the said parties of the second part the receipt whereof is hereby acknowledged do by these presents remise, release and forever quitclaim unto the said parties of the second part and to their heirs and assigns all right title and interest and estate of the said parties of the first part in and to all these certain lots pieces or parcels of land situated lying and being in the County of Skamania State of Washington and particularly bounded and described as follows to-wit:

The Southeast  $\frac{1}{4}$  of the Northeast  $\frac{1}{4}$  and the Northeast  $\frac{1}{4}$  of the Southeast  $\frac{1}{4}$  and the east  $\frac{1}{2}$  of the Southwest  $\frac{1}{4}$  and the South  $\frac{1}{2}$  of the southeast  $\frac{1}{4}$  of section 21 and the east  $\frac{1}{2}$  of the southeast  $\frac{1}{4}$  the southwest  $\frac{1}{4}$  of the Southeast  $\frac{1}{4}$  and the southeast  $\frac{1}{4}$  of the Southwest  $\frac{1}{4}$  of Section 22 also Lot 3 of section 27, all of said above described real property being in Township 3 North of Range 8 East of the Willamette Meridian. It is understood and intended by this deed that Mary Virginia Gray who was the daughter of Isadore St. Martin, deceased, does by these presents sell transfer and convey to the grantees all her right title and interest in the estate of Isadore St. Martin deceased and all title which she acquired therein by inheritance or otherwise.

Together with all and singular the tenements hereditaments and appurtenances thereunto belonging or in anywise appertaining and the reversion and reversions, remainder and remainders, rents issues and profits thereof. To have and to hold all and singular the said premises together with the appurtenances unto the said parties of the second part their heirs and assigns forever.
