THIS INDENTURE made and entered into this _____ day of May, 1912, by and between J.D. Welch and IDA.A. WELCH, his wife, of the City of Portland, County of Multnomah, State of Oregon, the parties of the first part herein; and the MAHAMA LUMBER COMPANY, a corporation organized, existing and doing business under and by virtue of the laws of the State of Washington, with it's principal place of business in the City of Vancouver, County of Clarke, State of Washington, the party of the second part herein, WITNESSETH:

That the said parties of the first part, for and in consideration of the sum of One Dollar, lawful money of the United States of America, and other good and valuable considerations, to them in hand paid by the said party of the second part, the receipt whereof is hereby acknowledged, have remised, released and forever Quit-claimed and do, by these presents, remise, release and forever Quit-claim unto the said party of the second part and unto its successors and assigns, all of our right, title and interest, of every name and nature whatsoever, in and to that certain Right-of-Way for the construction of a logging railroad over, across and upon the following described real estate situate, lying and being in the County of Skamania, State of Washington, and particularly described as follows, to wit:-
