MARSHALL TO KLINE

KNOW ALL MEN BY THESE PRESENTS, That H.F. Marshall of Carson, Washington the party of the first part, for and in consideration of the sum of Fifteen hundred ninety-six and 67/100 DOLLARS lawful money of the United State of America, to me in hand paid by Ettie L. Kline, the party of the second part, the receipt whereof is hereby acknowledged, do by these presents grant, bargain, sell, assign, transfer and set over unto the said party of the second part, a certain Indenture of Mortgage bearing date the 29th day of June A.D. 1916 made and executed by Mason G. Fifer, David Kline and Ettie L. Kline his wife, and Mason G. Fifer as Administrator of the Estate of Maytie Pearl Fifer, deceased to secure the payment of Fifteen hundred Dollars with interest thereon at 10 per cent per annum from June 29th 1916 until paid, and recorded in the office of the County Auditor of the County of Skamania State of Washington, in Book "N" of Mortgages, page 255 on the 3rd day of July, A.D. 1916 Together with the promissory note therein described, and the money due and to become due thereon with interest.

And the said party of the first part do hereby make, constitute and appoint the said party of the second part his true and lawful attorney, irrevocable in her name or otherwise, but at the proper costs and charges of the said party of the second part, to have, use and take all lawful ways and means for the recovery of the said money and interest; and in case of payment, to discharge the same as fully as the said party of the first part might or could do if these presents were not made.
