Long husband and wife grant to Northwestern Electric Company a perpetual right-of-way in and over the following described real property, situated in County of Clarke & Skamania, State of Washington, to-wit: Lot 1 in Section 1 T.1 N.R.4 E.W.M. and also across that certain tract of land conveyed to these grantors by deed dated Aug. 24, 1909, Recorded in Book M of Deeds page 32, records of Skamania County, Washington, for the purpose of erecting, maintaining and operating thereon, two pole or tower lines for the transmission of electric current; together with the right to cut such trees and brush as may be necessary in constructing, maintaining and protecting such lines from damage.
