Thomas, deceased, grant to Northwestern Electric Company a perpetual right-of-way in and over the following described real property, situated in County of Skamania, State of Washington, to-wit: Lot Three (3) section six (6) Township One (1) North Range Six (6) East of Willamette Meridian, Also across any part of Lot Two (2) in said section owned by the grantors for the purpose of erecting, maintaining and operating thereon, two pole or tower lines for the transmission of electric current; together with the right to cut such trees and brush as may be necessary in constructing, maintaining and protecting such lines from damage.
