In consideration of Fifteen Dollars the receipt whereof is hereby acknowledged, Olaf Anderson a bachelor grant to Northwestern Electric Company a perpetual right-of-way in and over the following described real property, situated in County of Skamania, State of Washington, to-wit: Beginning Thirty (30) rods south of the Northeast corner of Lot six (6) in Section Thirty-six (36) Township Three (3) North Range seven and one half ( $7\frac{1}{2}$ ) East of W.M. Thence West Twenty-six and two thirds ( $26\frac{2}{3}$ ) rods, Thence south ninety (90) rods to N. line Shepard D.L.C. Thence East Twenty six and two thirds rods ( $26\frac{2}{3}$ ) Thence North ninety (90) rods to beginning containing 15 acres more or less. for the purpose of erecting, maintaining and operating thereon, two pole or tower lines for the transmission of electric current; together with the right to cut such trees and brush as may be necessary in constructing, maintaining and protecting such lines from damage. The first line is surveyed and crosses the South east corner of said tract. The second or North line shall be constructed not to exceed 50 feet from and parallel to said first line.

Vallett to Northwestern Electric Company. ✓

In consideration of Twenty five Dollars the receipt whereof is hereby acknowledged, Henry Vallet, a single man, grant to Northwestern Electric Company a perpetual right-of-way in and over the following described real property, situated in County of Skamania, State of Washington, to-wit: That certain tract or parcel of land lying on the north side of the right of way of the S.P. & S. Ry. Company and south of the Carson road running east from Kanacker Creek (being between the County road and the said right of way) being a part of the tract of land owned by Mella Crowley in the Shepherd Donation Land Claim in Sec. 36 T. 3 N. R.  $7\frac{1}{2}$  E. W. M. for the purpose of erecting, maintaining and operating thereon, two pole or tower lines for the transmission of electric current; together with the right to cut such trees and brush as may be necessary in constructing, maintaining and protecting such lines from damage. The first or south line has been surveyed and staked out and on this line one pole or tower may be placed in the land not further than ten feet from the bank of the small creek running through the land. The second line shall be constructed within 50 feet of the first line but no pole or tower shall be placed in the land for this second line.
