Nelson, her husband grant to Northwestern Electric Company a perpetual right-of-way in and over the following described real property, situated in County of Skamania, State of Washington, to-wit: Lots Three (3) and Four (4) and the Northeast quarter of the Northwest quarter, also the North half of the Northeast quarter of section Thirty five (35) in Township Two (2) North, Range six (6) East of Willamette Meridian, Excepting about five acres more or less off the east end sold to Darr and Watson, Also excepting any land belonging to Wm. Butler. for the purpose of erecting, maintaining and operating thereon, one pole or tower lines for the transmission of electric current; together with the right to cut such trees and brush as may be necessary in constructing, maintaining and protecting such lines from damage.
