IVES TO PAQUET.

THIS INDENTURE, Made this 30th day of September, in the year of our Lord one thousand nine hundred and fifteen

BETWEEN S.B. Ives, otherwise known as Sherman B. Ives, an unmarried man, party of the first part, and Joseph Paquet, of Portland, Oregon, party of the second part:

WITNESSETH: That the said party of the first part, for and in consideration of the sum of One thousand (\$1000.00) Dollars, lawful money of the United States, to him in hand paid by the said party of the second part, the receipt whereof is hereby acknowledged, do by these presents Grant, Bargain, Sell, Convey and Warrant, unto the said party of the second part, and to his heirs and assigns, the following described tract or parcel of land, lying and being in the County of Skamania and State of Washington, and particularly bounded and described as follows, to-wit:

Lot numbered seven of Section 30, in twp. 2 North of Range 7 East of the Willamette Meridian, containing 54 acres; also the following described shore lands to-wit: Commencing at a point on the West or lower end of Ives Island, said point being 4879.85 feet south and 529.75 feet East of the Northwest corner of Sect. 30 Twp. 2 N.R. 7 E..W.M. and running thence north 38 deg. 50' feet; north 43 deg. 30' East, 270 feet; north 71 deg. 56' East, 1280 feet, north 82 deg. 06' east, 1010 feet; south 89 deg. 20' east, 703 feet, south 76 deg. 50' east, 240 feet; south 70 deg. 43' east, 240 feet; south 20' east 170 feet; south 36 deg. 50' west, 350 feet; south 51 deg. 35' west 430 feet; south 56 deg. 35' west 613 feet, south 60 deg. 50' west 580 feet; south 71 deg. 10' west, 766 feet; west, 338.45 feet; north 69 deg.
