GILLETTE TO BANK OF STEVENSON.

KNOW ALL MEN BY THESE PRESENTS, That I, J.P. Gillette in my own proper person and of my own right and J.P. Gillette as Guardian of the persons and estate of Elton Gillette and Harold E.
