KNOW ALL MEN BY THESE PRESENTS, That R.D. Shelley and Norene Shelley his wife, of Stevenson, Skamania County, Washington, the parties of the first part, for and in consideration of the sum of Ten Dollars and other values, Dollars, To them in hand paid by T.E. Hooker the party of the second part, the receipt whereof is hereby acknowledged, do by these presents grant, bargain, sell, convey and confirm unto the said party of the second part, his executors, administrators and assigns, the following described personal property, located and being in the barn of grantor on First Street, in Stevenson, County of Skamania, State of Washington. to-wit:

The horses, wagons, and livery Stable and Transfer business equipment of the said R.D.
