

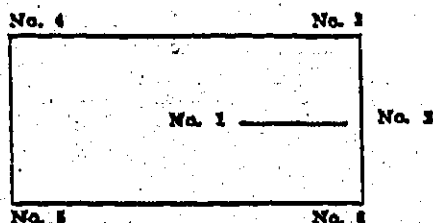

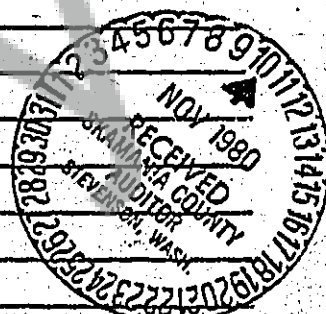
has located and does hereby locate 1500' linear feet in length, and 600' feet in width on the Lode Vein
