part thereof.on account of taxes, insurance or other lawful assessments, the holder hereof and the note secured hereby may immediately declare the whole of said principal sum, interest, taxes, insurance, charges and other assessments immediately due, and may thereafter in any manner provided by law, foreclose this mortgage, for the whole amount due, and may thereafter in any manner provided by law, foreclose this mortgage, for the whole amount then due on account of principal, interest, insurance, charges or other lawful assessments.

And in any suit or other proceedings that may be had for the recovery of said principal sums and interest on either said note or this mortgage, it shall and may be hand lawful for the said party of the second part its successors, executors, administrators, or assigns, to include in the judgement that may be recovered, (in addition to the costs provided by law) counsel fees and charges of attorneys and counsel employed in such foreclosure suit the sum of One Hundred DOLLARS, as well as all payments that the said party of the second parts successors, executors administrators, executors are may be abliged to make for them or their security by insurance or on account of any taxes, charges, incumbrances or assessments whatsoever on the said premises or any part thereof.
